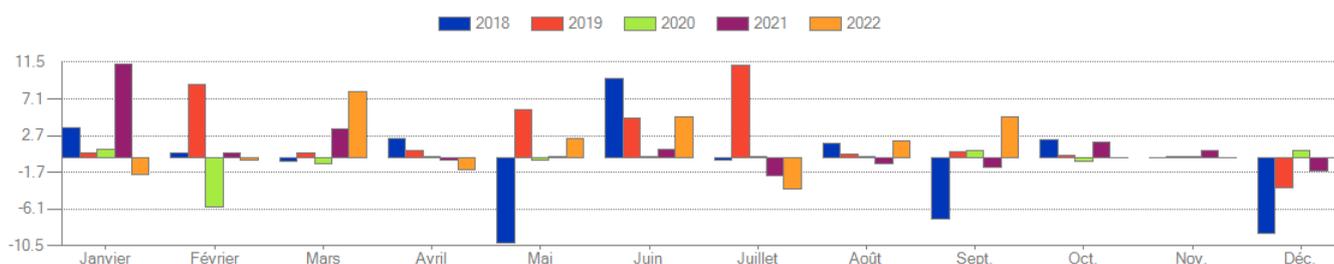

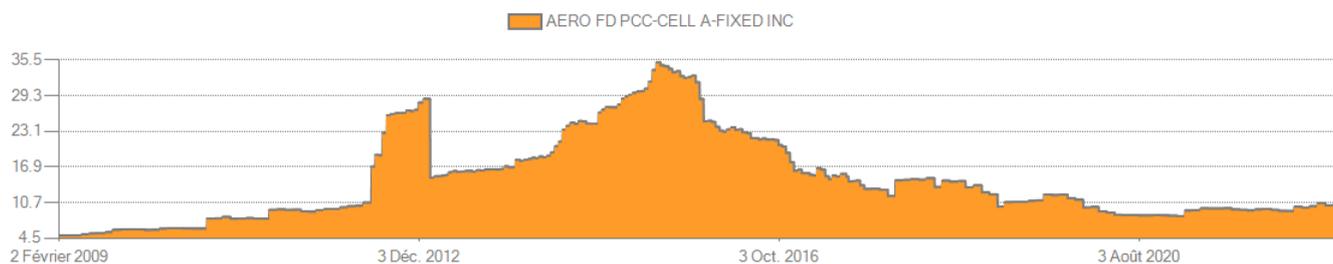

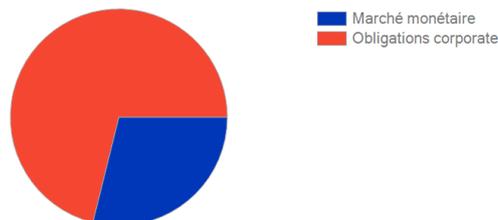

as of 06/30/2020

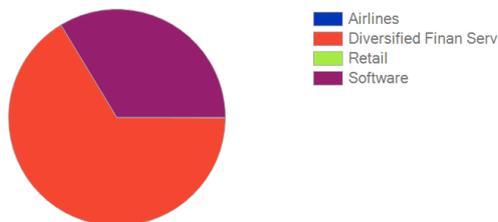

as of 06/30/2020

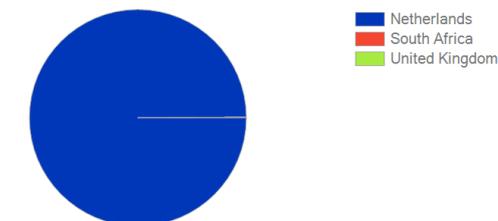
